Abstract:

Introduction: (Font size: 12; Line Spacing: 1.15)

The introduction should provide a brief overview of the topic of the article, and should state the research question or hypothesis that the article is addressing. It should also review the relevant literature on the topic.

Methodology: (if any) Explain the research design, approach, and methods used to collect and analyze data. Include details on participants, materials, data collection instruments, procedures, and statistical or analytical techniques.

Literature Survey/Review: Review relevant literature to establish the current state of knowledge in the field, highlight gaps, and demonstrate the need for your research. Discuss key theories, models, and previous studies.

Results: (if any) The results section should present the findings of the study. The results should be presented in a clear and concise manner, and should be supported by tables and figures.

Discussion: (if any) The discussion section should interpret the results of the study, and should discuss their implications for theory and practice. The discussion should also highlight the limitations of the study, and suggest directions for future research.
